Does it contain a minimum of 4-6 blank pages?
Expiration date: Must be <u>after 2 September 2016</u> .
2. Appropriate passport application form submitted (DS-82/DS-11/DS-64)?
Passport issued in the past? Use DS-82 if applicant:
1. Can submit his/her most recent U.S. passport book and/or U.S. passport card with this application.
2. Was at least 16 years old when his/her most recent U.S. passport book and/or U.S. passport card was issued.
3. Was issued his/her most recent U.S. passport book and/or U.S. passport card less than 15 years ago.
4. Uses the same name as is listed on his/her most recent U.S. passport book and/or U.S. passport card.
-OR-
5. Has had his/her name changed by marriage or court order and can submit proper documentation to reflect his/her name change.
No passport? Use DS-11
Lost or stolen? Use DS-11 and DS-64
<b>3.</b> Application form completed online? (Blank or handwritten forms are <u>not</u> accepted!)
<b>4.</b> Does barcode appear on the upper left side of application form? (This expedites processing by the State Department. <b>No</b> other version will be accepted!)
<b>5.</b> Does the application form include the following mailing address? (Ensures passport is set aside for pickup by the Passport and Visa Agent, NDU.)

<b>6.</b> Does the Travel Plan block on the application form include the following information?
<ul> <li>Length of stay - 13 days</li> <li>Departure date - 3/2/2016</li> <li>Countries to be visited - France, South Africa, China, Taiwan, Panama</li> </ul>

<sup>2</sup> Acceptable ID: most recently issued U.S. passport book or card, employee ID, driver's license (not temp or learner's permit), recently issued Certificate of Naturalization, aircraft pilot's license issued by the FAA.

<sup>3</sup> If one of the acceptable forms of ID is an out-of-state driver's license (not temp or learner's permit), i.e., issued anywhere other than Washington, DC, submit one additional form of ID. An employee ID or Common Access Card (CAC) is an excellent, additional form of ID.
