## NATIONAL DEFENSE UNIVERSITY (ES/NDU)

Below are prerequisites for all OCONUS Field Studies. All AORs require completion of:

- SERE 100.1
- ISOPREP
- AT/FP Level 1
- SOUTHCOM requires the addition of Human Rights Training and their General Order Number 1

**COMPLETE ALL REQUIREMENTS BEFORE YOU ARRIVE AT THE SCHOOL. PRESENT PAPER COPIES OF COMPLETION CERTIFICATES TO THE TEAM DURING IN-PROCESSING. (KEEP ORIGINALS FOR YOUR RECORDS). Do NOT email, fax, or digitally send this information to the APS staff otherwise.**

CONTACT THE ADMINISTRATIVE PERSONNEL AT YOUR PREVIOUS OR CURRENT COMMAND OR AGENCY FOR SUPPORT WITH COMPLETING THESE PREREQUISITES. THEY SHOULD BE ABLE TO HELP YOU COMPLETE THESE REQUIREMENTS.

**\*\*Survival, Evasion, Resistance and Escape (SERE) 100.1: (ALL COCOMS)**

**THIS COURSE TAKES APPROXIMATELY SIX-EIGHT HOURS TO COMPLETE.**

COMPLETION REQUIREMENT: **No older than** three years prior to last day of travel. Example: If last day of 2016 Industry Study travel will be 16 March 2016, then the completion date would need to reflect 16 March 2013 to be valid.

-A CAC card is required for this training. **Click on [https://www.fcg.pentagon.mil/static/SERE\\_100.1\\_Completion\\_Instructions.pdf](https://www.fcg.pentagon.mil/static/SERE_100.1_Completion_Instructions.pdf) for registration and completion instructions. Military: Enroll in Course # A-US022 to complete the training. Civilian: Enroll in Course # A-US 1282 to complete the training.** If you do not have a CAC card, please follow the instructions for non CAC users.

**Completed SERE Level C in-resident course? You still must complete this course within three years of traveling, per SOUTHCOM.**

**\*\*Isolated Personnel Report (ISOPREP): (ALL COCOMS)**

**COMPLETION REQUIREMENT:** Six months prior to last day of travel.

ISOPREPS must be created or reviewed no earlier than six months prior to completion of overseas travel. If unable to access SIPRNET and you have access to AKO, complete/submit the ISOPREP via the Army Knowledge On-Line (AKO) PRO-File tool located on the NIPRNET at:

DoD civilians and contractors will need a service member or sponsor CAC card to access Army Knowledge On-Line PRO-File web tool. Use normal AKO (or service equivalent) log in to access site. Civilians, never use ISOPREP? Click on

[http://www.mc.mil/portals/0/dd%20form%201833\\_isoprep.pdf](http://www.mc.mil/portals/0/dd%20form%201833_isoprep.pdf) to download the Isolated Personnel Report (ISOPREP) and ISOPREP completion instructions.

**\*\*Anti-Terrorism/Force Protection (AT/FP) Level 1: (ALL COCOMS)**

**COMPLETION REQUIREMENT:** One year prior to last day of travel.

Anti-Terrorism (AT/FP) Level 1 Training resides on Joint Knowledge Online (JKO), at <https://jkodirect.jten.mil>. Enroll in Course # JS-US007-14 to complete the training. If you do not have a CAC card, please follow the instructions for non CAC users.

**\*\*Human Rights Training/SOUTHCOM General Order Number 1: (SOUTHCOM ONLY)**

**COMPLETION REQUIREMENT:** One year prior to last day of travel.

Completion of Human Rights Training/confirmation of SOUTHCOM General Order Number 1 reviewed are required for visits to countries within the SOUTHCOM AOR, e.g., Mexico, Central America, Caribbean, South America.
